Every contestant represents not only herself but also the values of our community. We ask each participant to help create an environment where women inspire, support, encourage, and celebrate one another.

Terms and Conditions for Participation

This document constitutes an agreement between, you — the contestant or participant, and Las Vegas Long Hair LLC. By submitting your application to participate in events, activities, or contests organized and operated by Las Vegas Long Hair LLC (sometimes also referred to as LVLH), you agree to these terms.

In consideration of your engagement as a model, contestant, or other form of participant and for other good and valuable consideration herein acknowledged as received, you hereby grant the rights and permissions detailed in this document to Las Vegas Long Hair LLC ("Organizer"), its legal representatives, and assigns, those for whom Organizer is acting, and those acting with its authority and permission.

You warrant and affirm that you are at least 18 years of age and have the right to enter into contracts in your own name. You further affirm that you have read the entirety of this agreement, authorization, and release and are familiar with its terms. This agreement shall be binding upon you, your heirs, legal representatives, and assigns.

Withdrawing From Participation

If you do not wish to be bound by these terms and conditions, you may not participate in Las Vegas Long Hair LLC organized events, activities, or competitions. You may withdraw from events, activities, or competitions in writing to our email address info@lasvegaslonghair.com. Withdrawal ends your participation in activities, events, or competitions, but does not terminate media rights previously granted to Las Vegas Long Hair LLC.

Media Rights

By submitting your application, you grant Las Vegas Long Hair (LVLH) a worldwide, perpetual, irrevocable, royalty-free license to use, reproduce, publish, edit, composite, modify, distribute, display, reuse, republish, and promote all photographs, video content, and other materials you submit, by any means, including but not limited to, email, social media message, or communications app message, in whole or in part.

Such materials may be used across any existing or future media platforms, including but not limited to:

- The Las Vegas Long Hair LLC website, existing or future.
- Social media platforms, existing or future.
- YouTube.
- Digital and print publications.
- Advertisements.
- Promotional campaigns.
- Educational materials.
- Future LVLH events.

LVLH may edit, crop, translate, combine, or otherwise modify submitted materials, including producing derivative works, without requiring additional permission. No additional compensation will be provided for such use. For these purposes, you are considered to have submitted material if you send it through our website, social media messages (such as Instagram, WhatsApp, or Telegram), or email.

Use of Name, Image, and Likeness

By participating in activities, events, or competitions contestants grant Las Vegas Long Hair LLC, the right to use their name, likeness, voice, biography, photographs, videos, and any related content for promotional, marketing, archival, educational, and commercial purposes, worldwide and in perpetuity, without additional notice or compensation.

Use of your name, image, and/or likeness may include but is not limited to;

- The right to sell merchandise containing a participant's image or likeness
- The right to license video or audio from events, activities, or competitions to third parties.
- The right to use your name, image or likeness in paid advertising.
- The right to use AI-assisted tools to edit, enhance, modify, or create derivative works from submitted materials.
- The right to alter captions, translations, or presentation of submitted materials.
- The right to continue using name, image, or likeness in the event that a participant withdraws or is disqualified from a competition.

Privacy

A public contest requires public information about its contestants and participants. By participating, contestants consent to the publication of information related to any activities, events, or competition for the purposes of promoting or conducting an activity, event, or competition including:

- Participant's name or chosen display name.
- Country of residence and/or origin.
- State or province represented by participant.
- Photographs in which you may appear.
- Video content in which you may appear.
- Competition results.

Organizer Rights

Las Vegas Long Hair LLC reserves the right to:

- Modify contest rules.
- Change dates, schedules, or deadlines.
- Adjust competition procedures.
- Postpone, suspend, or cancel the competition if the Organizer, in its sole discretion finds it necessary.
- Disqualify contestants who violate these policies.
- Refuse or revoke participation when the Organizer reasonably determines it is necessary to protect LVLH, the competition, its participants, or the LVLH community.

Voting Policy

Any attempt to manipulate the online voting process is strictly prohibited.

This includes, but is not limited to:

- Using bots or automated voting.
- Purchasing votes.
- Any form of paid service to generate votes, such as "vote farms" or similar services.
- Duplicated or fabricated accounts for the purposes of inflating a participant's vote totals.
- VPNs or device manipulation intended to evade voting limits.

In the event of suspected vote manipulation, the Organizer retains the right to:

- Investigate suspected votes.
- Remove invalid votes.
- Suspend a participant's profile during an investigation of suspected vote manipulation.
- Make final determinations as to vote validity.

Any violation by a participant or a participant's representative may result in suspension of the participant's profile and may have consequences up to disqualification from present and future events, activities, or competitions.

Officers and employees of Las Vegas Long Hair LLC are prohibited from voting in any competition organized by Las Vegas Long Hair LLC.

Official judges for live competitions are permitted to vote in online competitions as members of the public. Judges for the live competition are not considered employees for the purposes of voting in online competitions.

Participant Responsibilities

This section lists actions that may be asked of participants in activities, events, or competitions organized by Las Vegas Long Hair LLC. This list is not comprehensive.

Promotional Participation

Contestants are encouraged to actively support and promote the activities, events, or competitions by:

- Sharing their official contestant profile on social media or other media.
- Reposting Las Vegas Long Hair LLC social media content.
- Engaging positively with the community.
- Representing Las Vegas Long Hair LLC in a respectful and professional manner before, during, and after involvement in any activity, event, or competition.

Code of Conduct

All contestants are expected to represent themselves and the LVLH community with kindness, respect, and professionalism.

Participants agree not to:

- Harass or bully other contestants.
- Spread false or misleading information.
- Create unnecessary conflict or intentional distress.
- Engage in abusive, offensive, or discriminatory behavior.

Organizer reserves the right to remove or disqualify any participant whose behavior negatively affects activities, events, or competitions or the community.

Reputation

The Organizer reserves the right to suspend or remove any contestant whose public conduct may seriously damage the reputation, integrity, or values of the organization.

This includes, but is not limited to:

- Hate speech.
- Harassment.
- Illegal activities.
- Public misconduct.
- Knowingly or recklessly publishing materially false information concerning LVLH, its competitions, officers, employees, staff, or other participants.
- Actions that significantly harm the LVLH community.

Good-faith complaints, truthful statements, reports of misconduct, and lawful participation in legal or regulatory proceedings will not, by themselves, constitute a violation.

Copyright Responsibility

Contestants confirm that all submitted materials are their own or that they have obtained all permissions and rights necessary to submit the materials and grant LVLH the rights described in this agreement.

Participants are solely responsible for any copyright or intellectual property claims related to their submissions.
